Article 3. To raise and appropriate as an operating budget, not including appropriations by special warrant articles and other appropriations voted separately, the amounts set forth on the budget posted with the warrant or as amended by vote of the First Session, for the purposes set forth therein, totaling sum of \$1,508,203 (One Million Five Hundred Eight Thousand Two Hundred Three Dollars). **Selectmen recommend this article by a vote of 3 to 0. Budget Committee recommends this article by a vote of 6 to 1.**

Should this article be defeated; the operating budget shall be \$1,558,470 (One Million Five Hundred Fifty Eight Thousand Four Hundred Seventy One Dollars) which is the same as last year, with certain adjustments required by previous action of the Town or by law; or the governing body may hold one special meeting, in accordance with Chapter 40:13, X and XVI, to take up the issue of a revised operating budget only.

The total amount to be taken from the Fire Department and Ambulance Equipment, Apparatus and Personnel Special Revenue Fund. This article is contingent on the passage of Article 17. No money to be raised through taxation. **Selectmen recommend this article by a vote of 2 to 0. Budget Committee does not recommend this article by a vote of 4 to 2 with 1 abstaining.**

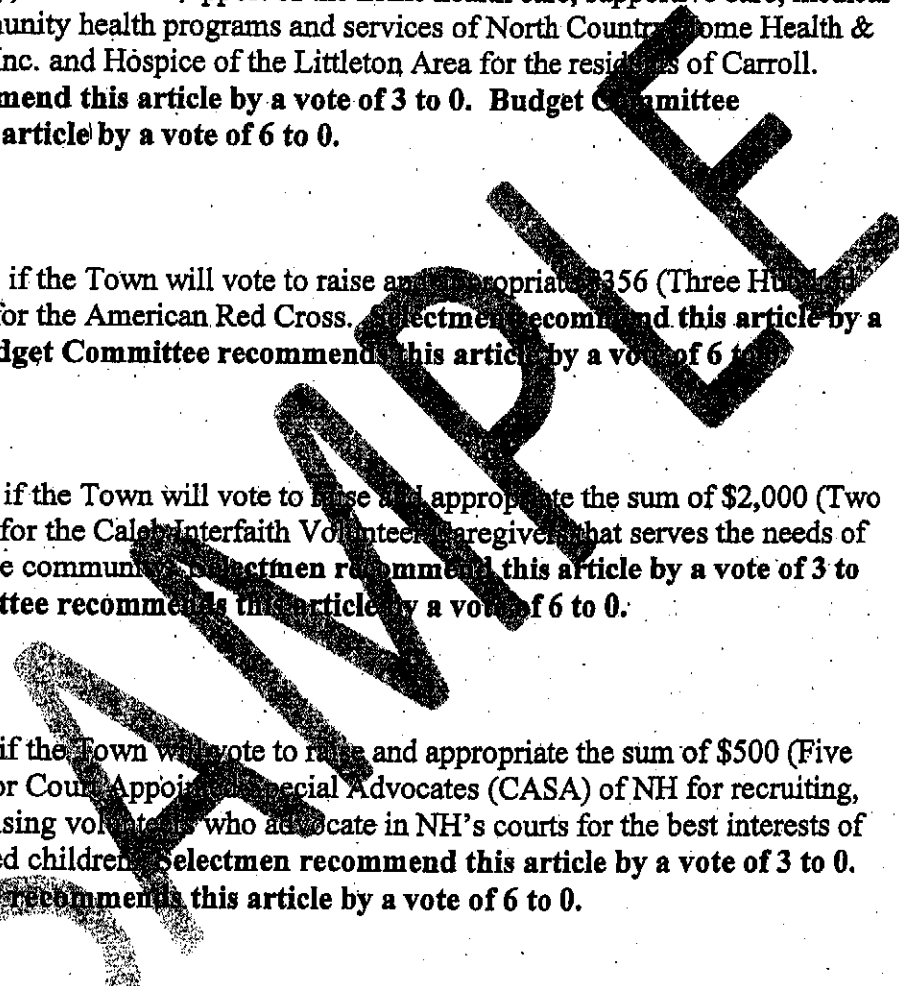
