RE: Selectmen's 2013 Budget submission to the Budget Committee

Dear Members of the Board:

On September 27, 2012, I sent an e-mail to all of you in which I outlined the Selectmen's responsibility regarding giving the Budget Committee "all necessary information", "at such a time as the budget committee shall fix" (RSA 32:17)

To be clear, the information the Budget Committee deems necessary is;

- 1. your 2013 budget
- 2. department requests and back-up information
- 3. job descriptions

The time "fixed" was Labor Day. The Committee understood that the Selectmen needed extra time to vote and allowed two additional weeks for the Selectmen to finish the process. When none of the above necessary information was forwarded to the Budget Committee, the e-mail of September 27, 2012 was generated.

Gentlemen, we are now squarely into October. At the Budget Committee meeting of October 3, 2012, the Budget Committee was still not in receipt of the above necessary information. I am now forced to refer you to RSA 32:12 "Penalty – Any person or persons violating the provisions of this subdivision shall be subject to removal from office" The State of New Hampshire does not allow one entity in a municipality to take another entity in the same municipality to court. The Budget Committee is hopeful that this "problem" will be addressed quickly and completely so that further communication of this sort is not necessary.

The Budget Committee needs the listed information to function properly and produce a reasonable budget for the Town. The Committee has no idea why this cannot be accomplished but the Committee also will not be held to blame for consequences brought about by what appears to be the Board's inaction on this matter. This is not a frivolous issue and should not be taken lightly by the Board of Selectmen.
