Bonnie et. al.,

We have been through all this before. In 2008, After sending out a "Request for Proposal" (copy attached, which I wrote) to 12 Design Builders, we selected and contracted with Bonnett, Page and Stone to produce Design Build Drawings and Outline Specifications for a new police facility located on the sliding hill behind the Town Hall with an entrance a egress to US Rte. 3 on the western side of Rte. 3 and across the street from the current fire station. We have 70% plans for the Proposed Police facility developed after several meetings with the Building Committee, Police and Fire personnel and interested Citizens. The entrance/egress would require a wetland permit. The plans included extensive site work to prepare the site not only for the proposed Police facility but also to provide future space for a new Fire facility.

We already have drawings and specification for a proposed Police Facility. Why would we want to burden the Town with the expense of starting all over again? The Board of Selectmen need to do more than "go along with a warrant to acquire plans for a Police Station only, to be built on property that is already owned by the town." They will need to get involved with the project so that they can fully understand it, be able to speak intelligently about it and ENTHUSIASTCALLY get behind it AND the Building Committee when recommending it to the voters. Bonnie, I am sure that you remember that even though the Board of Selectmen serving in 2008/2009 asked the Building Study Committee to come up with a proposal for a new Police Facility, when it came to presenting it to the voters in March of 2009, it quickly became OUR (yours and mine) proposal. I won't go through that again.
